CONDITIONS FOR BECOMING A MEMBER

The International Foundation ORP was established on 13 October, 2013 registered in public deed number 2.113, before the honourable public notary D. Juan Manuel Álvarez-Cienfuegos Suárez, resident of Terrassa and member of the College of Notaries of Catalunya. On 16 April, 2015, before the same notary a complementary public deed with number 814 was granted, following which the inscription was listed in the Foundations Registry by Ministerial order on 4 May, 2015 and assigned the registration number 1740.

FiORP is a private and independent non-profit organization dedicated to improving the quality of life in the workplace through innovation and the spread of information regarding the same in all formats The objective of FiORP is to foster and carry out multidisciplinary projects focused on raising awareness and developing training in accordance with the current market society.

Within its framework, FiORP has created the **International Network of Healthy Companies (RiES, from this point forward)** which is an alliance of companies committed to carrying out and promoting collaborative actions which highlight good practices in the integral development of both the people and the company, thus nurturing Sustainable Companies.

1. REGISTRATION OF MEMBERS

Membership to RiES requires filling out the registration form available on the website www.fiorp.org.

2. JOINING THE NETWORK

By requesting to be a member of RiES, it is understood that a corporation commits to fulfilling the stipulations outlined in this contract and, as said member, will therefore have the right to receive those services offered by FiORP. The costs associated with these services whether through FiORP or external collaborators, are assumed by the member entity. Membership and renewal of membership in RiES implies the acceptance by the member of the conditions outlined by RiES at the time of said renewal. FiORP reserves the right to accept or deny the renewal.

3. USE OF THE RiES BRAND

Members can use the RiES logo distinguishing them as members of the network according to the rules outlined in the user manual for use of the brand of the International Foundation ORP.

4. PAYMENT OF MEMBERSHIP FEES

Members agree to pay the corresponding fees according to the current registration contract.

5. VALIDITY AND RENEWAL

Membership is renewed on an annual basis, unless a member decides to withdraw, or a member fails to fulfill the conditions for renewal. Annual quotas are mandatory as a member of RiES. If, after one calendar month of the expiration date of the renewal, a member is not in good standing, the membership can be automatically unregistered by FiORP. If a membership is discontinued before the end of the first year, or in the middle of any successive years, the proportional amount of the annual fee will not be reimbursed, regardless of whether the decision is made by the member or by FiORP. Notwithstanding, all rights as a RiES member will remain in vigor for the duration of the time period covered by the payment.

6. WITHDRAWAL OF MEMBERSHIP

Withdrawal as a member of RiES, for whatever reason, assumes renouncing all rights and advantages offered to members. Requests for withdrawal must be made in writing and addressed to:

7. CONFIDENTIALITY AND DATA OF MEMBERS

In accord with the provisions set forth in the law 34/2002, on 11th of July, by the Information Society and Electronic Commerce Services and of the European Parliament Reglamenteary 2016/679 related to personal data protection and circulation of this data, members are informed and agree to the recording of said data by the International Foundation FiORP, Buen Gobernador 16 – 28027 Madrid as well as its circulation, including via electronic means, communication and/or publications related to the various services, programs, projects and workshops of the member entity. Members have the right to access, rectify, cancel and refuse use of this data, if requested in writing at the aforementioned address. In accordance with the above, Members authorize FiORP to store the data provided by the entity itself as well as that obtained by means of its activities with RiES,

and to automate and deal with the information as seen fit for the correct maintenance of services offered and outsourced. Additionally, members authorize access to this data by RiES collaborators in order to provide services to member companies.

8. COMMUNICATION

Members authorize FiORP to periodically send information related to activities and commercial offers through various means of communication: electronic mail, post, SMS, as in agreement with the information on the membership form. 9. LEGAL FRAMEWORK AND JURISDICTION

This contract is regulated according to pre-established specifications. Should this fail and the parties do not reach an agreement the regulation will be according to current Spanish laws, mercantil and civil, issued by the European Union. For any controversy which may arise from the preparation, fulfillment, effects or contract termination, FiORP and the member entity, with express waiver of their own jurisdiction, will submit to the Court of the city of Madrid.
